Providence Regional Medical Center Everett (PRMCE) is an award winning 571 bed, not-for-profit level II trauma center. With two campuses located in Everett, thirty miles north of Seattle, PRMCE offers comprehensive medical and surgical services and is a tertiary regional referral center serving the five-county region of Snohomish, Skagit, Whatcom, Island and San Juan communities.



### Comprehensive Training in Acute Care

At PRMCE, pharmacy services are dedicated to the organization's overall mission to provide exceptional patient care through our core values of Compassion, Dignity, Justice, Excellence and Integrity. During your residency training, you will have a chance to develop advanced clinical skills in a progressive pharmacy department. The program takes advantage of the many services provided including but not limited to orthopedic, neurosurgery, cancer, heart and vascular, cardiology, obstetrics, infectious disease, critical care, emergency and trauma care, neonatal/pediatric, inpatient rehabilitation, and behavioral health services. PRMCE is part of the Seattle Children's pediatric network, Providence Regional Cancer Partnership with the Everett Clinic, Western WA medical group, and NW Radiation Oncology, and operates the busiest emergency department in the state.

### Pharmacy Residency Program Overview

The Providence Regional Medical Center Everett PGY1 pharmacy practice residency is a 12-month ASHP accredited program offering four resident positions.

#### Program Objectives

PRMCE is committed to the well-rounded development of pharmacy practitioners. With a robust presence in all clinical areas, the residency program will provide the residents with opportunities to develop the clinical skills to provide excellent direct patient care. The resident will also develop a strong foundation in critical thinking, communication, and clinical decision making through participation in pharmacy administration activities, interactions with the interdisciplinary healthcare team, and participation in clinical committees. Pharmacists who complete the residency program will be candidates for PGY2 training, specialized clinical positions, and/or eligible for board certification. Opportunities to precept and teach through affiliation with both the University of Washington and Washington State University Colleges of Pharmacy and Medicine are available.

#### Staffing

Part of your training will involve staffing every other weekend for a total of 21 weekends throughout the residency year. Staffing includes both the central distribution pharmacy and decentralized clinical shifts in order to ensure the resident is capable to staff in all distribution and clinical areas upon completion of the PGY1 program.

#### Residency Project

All residents will complete a year-long project based on departmental needs and resident interest. The project will be presented as a poster at ASHP Midyear Clinical Meeting and at a regional conference at the end of the residency year. In addition, the project must be submitted in written form as a manuscript prior to the completion of the residency year.

## Rotations Offered

PRMCE offers a broad selection of rotations to meet your specific professional goals. Rotations are selected and length of experience is determined based on the interest of the resident. Through our PGY1 program, you will gain the broad experience necessary for a successful career as an acute care clinical pharmacist.
