Providence Regional Medical Center Everett (PRMCE) is 597-bed community hospital located in northwest Washington State. PRMCE is part of the Providence St. Joseph Health System which operates over 50 hospitals across seven states. With two campuses located in Everett, Providence Everett offers comprehensive medical and surgical services as a regional referral center serving the rapidly growing Snohomish, Skagit, Whatcom, Island and San Juan counties. The PGY1 residency program takes advantage of the many services provided at PRMCE including but not limited to orthopedic, neurosurgery, cancer, heart and vascular, cardiology, obstetrics, infectious disease, critical care, emergency and trauma care, neonatal/pediatric, inpatient rehabilitation and behavioral health services.

The pharmacy department at PRMCE takes a proactive role in the improvement of medication practices by utilizing available technology to create processes that are safe, efficient and cost-effective. Additionally, our pharmacists are committed to the development and expansion of the pharmacist's role in direct patient care. Clinical practices includes an extensive collaborative drug therapy management agreement and many pharmacist-initiated processes that improve the stewardship of medications leading to improved medication management and outcomes for patients across all care settings. These practices have resulted in the pharmacy being a well-integrated participant in multidisciplinary teams throughout the medical center.

Pharmacy Residency Program Overview

The Providence Regional Medical Center Everett PGY1 pharmacy practice residency is a 12-month ASHP accredited program offering four resident positions.

Purpose Statement

PGY1 residency programs build upon Doctor of Pharmacy (PharmD) education and outcomes to develop pharmacist practitioners with knowledge, skills, and abilities as defined in the educational competency areas, goals, and objectives. Residents who successfully complete PGY1 residency programs will be skilled in diverse patient care, practice management, leadership, and education, and be prepared to provide patient care, seek board certification in pharmacotherapy (i.e., BCPS), and pursue advanced education and training opportunities including postgraduate year two (PGY2) residencies.

Program Objectives

PRMCE is committed to the well-rounded development of pharmacy practitioners. With a robust presence in all clinical areas, the residency program will provide the residents with opportunities to develop the clinical skills to provide excellent direct patient care that proactively advocates for their patients. The resident will also develop a strong foundation in critical thinking, communication, and clinical decision making through participation in quality assurance projects, patient safety initiatives, formulary development, and participation in interdisciplinary committees. Opportunities to precept and teach through affiliation with both the University of Washington and Washington State University Colleges of Pharmacy and Medicine are available.

Staffing

Part of your training will involve staffing every other weekend for a total of 22 weekends throughout the residency year. Staffing includes both the central distribution pharmacy and decentralized clinical shifts to ensure the resident is capable to staff in all distribution and clinical areas upon completion of the PGY1 program.

Rotations Offered

PRMCE offers a broad selection of rotations to meet your specific professional goals. Through our PGY1 program, you will gain the broad experience necessary for a successful career as an acute care clinical pharmacist.

- Pharmacy Distribution: 3 weeks
- Introduction to Pharmacy Administration: 3 weeks
- Internal Medicine: 6 weeks
- Antimicrobial Stewardship: 5-6 weeks
- Emergency Medicine: 4-6 weeks
- Medical Intensive Care: 5-6 weeks
- OB/Neonate Experience: (Select 1)
 - Obstetrics and Newborn Care: 2 weeks
 - Neonatal Intensive Care: 4-6 weeks
- Oncology Experience: (Select 1)
 - Introduction to Oncology: 2 weeks
 - Oncology: 4-6 weeks
- Precepting Internal Medicine: 4 weeks
- Professional Development: 2 weeks

Longitudinal Required:

- Major Project: 48 weeks*
- Distribution Staffing: 20 weeks

The residency program supports travel to ASHP Midyear and at a regional conference at the end of the residency year.

Completed applications will only be accepted through the Pharmacy Online Residency Centralized Application Service (PhORCAS) at ashp.org/PhORCAS no later than the application deadline date of January 2nd. Applicants must submit the following:

- Curriculum vitae
- Hand-written or typed supplemental questionnaire (see website for questions)
- Three letters of professional recommendation
- One official copy of college of pharmacy transcripts
