Providence Regional Medical Center Everett (PRMCE) is an award winning 530-bed, not-for-profit level II trauma center. The institution is part of the Providence St. Joseph Health System, which operates 50 hospitals across seven states in the Western United States. Located in Everett, thirty miles north of Seattle, PRMCE offers comprehensive medical and surgical services and is a tertiary regional referral center.

Pharmacy Residency Program Overview

The Providence Regional Medical Center Everett PGY-1 pharmacy practice residency is a 12-month ASHP accredited program that builds on the Doctor of Pharmacy (Pharm.D.) education. Four resident positions are recruited from candidates throughout the United States.

Preparation for Advanced Pharmacy Practice

- PRMCE department of pharmacy provides 24-hour acute care service and decentralized patient care with a robust presence in all clinical areas
- Residents will develop a foundation for critical thinking and clinical decision making for medication-related care of patients with a wide range of conditions
- Pharmacists who complete the program will be strong candidates for clinical positions, eligible for board certification and PGY-2 training
- Residents will be part of interdisciplinary healthcare teams and will participate in several clinical committees
- Opportunities to precept and teach through affiliations with both the University of Washington and Washington State University Colleges of Pharmacy

Staffing

- Part of your training will involve staffing two weekends a month following orientation, a total of 21 weekends throughout the residency year
- Staffing includes both the main central distribution pharmacy in order to help ensure you are competent in the operational side of hospital pharmacy and understand how it impacts patient care as well as decentralized services in all rotations you have successfully completed

Residency Project

All residents will complete a year-long project based on departmental needs and resident interest. The project will be presented at the Western States Residency and Preceptor Conference held each spring and at ASHP Midyear Clinical Meeting in December. In addition, the project must be submitted in written form as a manuscript prior to the completion of the residency year

Comprehensive Training in Acute Care

At PRMCE, pharmacy services are dedicated to the organization's overall mission to provide exceptional patient care through our core values of Justice, Excellence, Respect, Compassion and Stewardship. During your residency training you will have a chance to develop advanced skills in a progressive pharmacy department. The program takes advantage of the many services provided at PRMCE and offers a broad selection of rotations to meet your specific professional goals. Through our PGY-1 program, you will gain the broad experience necessary for a successful career as an acute care clinical pharmacist.

Receive Salary, Benefits and Travel Opportunities

Pharmacy residents are eligible to receive benefits that include medical, prescription, vision and dental coverage (for you and your dependents). Residents will receive ten days of personal time off (PTO) in addition to hospital observed holidays. Administrative leave and paid travel is provided for ASHP Annual Midyear Clinical Meeting and Western States Pharmacy Conference.

Applicant Requirements

To be considered for the PGY-1 Pharmacy Residency, you must be registered with the ASHP Matching Program and all applications are submitted via PhORCAS. Prior to the start of the program, the resident will have graduated from an ACPE accredited college or school of pharmacy and shall be licensed or eligible for licensure in the State of Washington. Residents not licensed as a pharmacist at the beginning of the residency must be licensed as a pharmacy intern with the State of Washington and all candidates should complete their pharmacist licensure within 90 days of starting the program.

Applicants must pass all Providence employment screenings including but not limited to drug screens, background and health screening. Applicants must be eligible to work in the United States as PRMCE does not sponsor any visa requests.

Strong residency candidates must possess excellent verbal and written communication skills, demonstrate a pattern of professionalism and leadership, as well as being committed to patient focused pharmaceutical care

How to Apply

To be eligible for the PRMCE PGY-1 Acute Care Pharmacy Residency, applicants must submit the following as required via PhORCAS no later than January 1st.

- Cover letter, stating reasons for applying to PGY-1 and why you want to train at PRMCE
- Curriculum vitae
- Hand-written or typed supplemental questionnaire (see website for questions)
- Three letters of professional recommendation
- One official copy of college of pharmacy transcripts
